Leading the Way to Healthy Communities

In September 2022 I joined Barrett Hospital & HealthCare as the new Chief Executive Officer. It has been an honor to join the Dillon community and lead an organization that has been serving the area for more than 100 years, making health a top priority.

Barrett Hospital & HealthCare

believes that one of the best ways to advance the health and well-being of rural communities is to provide services, support, and education to families as close to home as possible. Keeping their care local through primary care, walk-in, and specialty clinics, as well as electronic information and telecommunication technologies for other family-centered care programs.

Our telehealth services for primary care and mental health have seen increased demand while providing care at the patients' convenience. These virtual visits were such a success that we also added a telesleep clinic as a service, making it possible for adults and children suffering from sleep disorders to receive initial evaluations and specialized exams without having to wait for a specialist to be available in person. With these new processes in place, one of our respiratory therapists visits with the patient, right after sleep therapy begins, to help with patient education and ensure compliance. This also has helped us diagnose those patients with advanced sleep disorders that may need a follow-up appointment with the sleep medicine physician. The physician can see the patient as either a telemedicine visit or in person in Billings, depending on the patient's preference. After that, if needed, we follow up with the patient on a monthly basis until the patient is comfortable with the provided therapies and sees success.

We've improved our clinic flow by utilizing MyChart functions, so we can increase access to appointment scheduling options both through the electronic application and via text messages. This allows patients to be seen sooner, and more frequently, by their regular primary care provider.

Barrett Hospital & HealthCare understands that building a healthier community often requires a combined effort. It's been our privilege to collaborate with organizations that hold a special understanding of the health disparities in Southwest Montana. We continue to work with the Beaverhead County Public Health Department, and in 2023, we will be collaborating on a Community Health Needs Assessment. This assessment will ensure we hear from our local community members directly, providing us with vital information and ensuring we know how to optimize our care to meet our community's specific health needs.

As I look ahead, I'm confident our commitment to deliver quality care is only growing stronger. While Barrett Hospital & HealthCare is not immune to the many challenges and uncertainties facing the health care industry, we will remain focused on ensuring that we have a strong and sustainable hospital and health system that provides the highest quality care to those we serve. It is a responsibility that every member of the Barrett team holds sacred, and we will continue honoring our promise to provide compassionate care, healing, and health-improving service to all community members throughout their life journeys. This is at the heart of everything we do.

Keeping the Healthof Our Community **Top of Mind**

No matter what challenges we face, the health of our community is always our top priority. Despite being a smaller community, we are provider-rich when compared to other models across the country. The family practice doctors and internal medicine doctors are very cognizant of preventative care, and their initiative has allowed them to detect diseases like diabetes, hypertension, and heart disease early–effectively preventing the complications caused by these

conditions. In a community full of ranching, hard-working cowboys, that's crucial.

We have a full team of medical providers for a Critical Access Hospital, including Internal Medicine, Family Practice, Obstetrics, General Surgery, Orthopedics, and Emergency Medicine. This offers patients access to most day-to-day and emergency care one would need without having to travel long distances to larger towns. The key is to have ample providers in each of these specialties to be able to accommodate patient needs. Our goal is to provide 24/7 coverage to treat and stabilize all patients' needs with hopes that they can stay in our community for continued care, and if they can't, then we have the resources to refer and transfer their care to a specialist in our regional area.

In an effort to constantly enhance the level of care we provide, we have several mental health providers and social workers with mental health backgrounds in our community that have opened offices and practices. Our contract with Providence Health & Services provides our patients with access to Telepsychiatry, connecting them to a licensed psychiatrist. This allows quick access to mental health professionals who can provide evaluations remotely and help with direct care. When someone faces a mental health emergency, Telepsychiatry provides us with the ability to connect with a psychiatrist to evaluate the patient and provide recommendations 12 hours a day, 7 days a week. While mental health services are in high demand all over the country, mental health professionals are still in short supply. This arrangement enables us to service those in need of urgent interventions without waiting for an in-person appointment. This allows medication adjustments and decisions about inpatient versus outpatient treatment to be done quickly.

Despite staffing shortages across the country, we are lucky to enjoy highly trained, dedicated staff at Barrett. Critical Access Hospitals and smaller communities can offer the attraction of a better family lifestyle with less stress than larger facilities and towns, which is why we have been able to pivot better than

larger hospitals despite this nationwide dilemma. We believe there is a benefit to reaching into the local community, which is why we support and prioritize hiring and training people who live in the area and understand the local lifestyle. We refer to this as "raising and attracting our own" here at Barrett.

I want to thank the community on behalf of Barrett Hospital & HealthCare for their continued patience, resilience, and trust in Barrett Hospital & HealthCare with their health and lives. I also want to express my gratitude to our staff members who continue to share their passion for their community in their day-to-day work, providing the best level of health care in our area.




